Addendum dated *2/17/2009*
 To the terms and conditions
 Dated as of September 12, 2008 (the "Agreement")
 Between CDW Government, Inc. ("Supplier")
 And Iowa State University ("ISU")

The terms and conditions of this Amendment shall be incorporated into the Agreement and supersedes the Agreement to the extent expressly provided herein. Each capitalized term used herein and not otherwise defined shall have the same meaning attributed to it in the Agreement.

The terms and conditions of the Agreement are hereby modified:

Section 3.2. Discount Structure

CDW-G will provide a discount structure based upon CDW-G's published retail price minus a defined discount. Supplier agrees to provide the increased discounted pricing below for all orders placed though the ISU Sciqwest platform.

Below are ISU's responsibilities as part of this addendum to increase the pricing discount for orders placed though the ISU Sciqwest platform.

3.2.1 Allow CDW-G to refer to themselves as a CyBuy marketplace vendor to ISU in both written and verbal communications.

- 3.2.2 Work with CDWG to direct a communication to clients across campus on an ongoing basis to promote our CDWG's CyBuy Marketplace presence, monthly product promotions, etc. ISU will have the opportunity to review any marketing information regarding CyBuy prior to its release.
- 3.2.3 Assist, when possible, to secure a room and help distribute information on the meeting to users, for on-campus events as requested by CDWG (no more than quarterly).
- 3.2.4 Meet with CDW-G representatives for a business review and to assess how we can enhance our relationship as requested by CDWG (no more than quarterly).
- 3.2.5 Provide CDW-G ISU's departmental rollout schedule for CyBuy as requested by CDWG (no more than monthly).

Except as modified herein, all other terms and conditions of the Agreement shall remain in full force and effect.
