

Addendum dated as of 7/30/2013
 To the terms and conditions
 Dated as of September 12, 2008 (the "Agreement")
 Between CDW Government, Inc. ("CDW-G")
 And Iowa State University ("ISU")

The terms and conditions of this Amendment shall be incorporated into the Agreement and supersedes the Agreement to the extent expressly provided herein. Each capitalized term used herein and not otherwise defined shall have the same meaning attributed to it in the Agreement.

The terms and conditions of the Agreement are hereby modified:

Section 2.12 Term of the Agreement

Under the terms of the original agreement, CDW Government LLC and Iowa State University extend the terms for an additional five (5) years. The new extended expiration date will be June 30, 2018.

Section 3.2. Discount Structure

CDW-G will provide a discount structure based upon CDW-G's published retail price minus a defined discount.
